CORPORATE PACKAGES 2025

RULES:

- Prior to any corporate joining for the year of 2025, an introductory meeting will be held by the COO and Golf Directors.
- Corporate bookings are for clients and guests ONLY. Under no circumstances shall a member of Serengeti be put under a corporate booking for the day of play.
- Bookings need to be made no later than 24 Hours before date requested and will only be booked through the COO, Golf Directors, The Membership Consultant or ProShop.
- A designated person from the corporate company must make the booking and supply the details of the players in the booking.
- Each corporate booking can only consist of up to 8 x Fourballs on a day, Subject to availability.
- Any no show for the booking shall result in a penalty of R800 per player and must be paid before their next booking can be made.
- Membership is included in the corporate membership, as per the above packages, and cannot be removed. Additional fees such as HNA Membership Card may apply. Additional membership may be added at a extra cost as per the breakdown of the package chosen.
- The corporate is responsible for their own golf rounds and carts purchased through the package and CANNOT be re-sold or traded. If not adhered to, the party shall forfeit their corporate membership with Serengeti until a decision is made.
- The corporate membership is not transferable to the year following.
- The corporates are responsible for their clients or guests for the duration of their stay with us at Serengeti. Any damage or misconduct caused will result in the corporate being held liable.
- The corporate member will be required to always play with their clients or guests when making a booking. If said member is not with the group on the day of play, they will not be allowed to play on any of Serengeti's facilities, unless agreed upon by the COO or Golf Director prior to the day of play.
- If a corporate member wishes to play outside of their designated days of play, they shall be charged a member green fee and cart rate, whereas their clients shall pay a member guest rate for green fee and carts.
- All Other Expenses for the players own accounts
